**LEGISLATURE ADJOURNS
 WITHOUT SPENDING
 FUNDS**

The 2010 Legislature adjourned in mid-April with thoughts they may be returning during the summer or fall for more budget cutting. During the session, Legislation containing any funding or revenue needs met almost instant death in Committees and on the floor of the Legislature. Having just come off the November 2009 Special Session of cutting \$324 million dollars, Senators and the Governor were reluctant to spend any additional dollars.

The economy keeps moving along and revenue forecasts haven't brought back ideas of a Special Session thus far this year.

There were two pieces of legislation affecting the towing industry. The first was LB 1092, introduced by Senator Steve Lathrop of Omaha. The bill would have required that towing and storage fees could not be set at a rate that is more than the amount that the city or county would pay for towing services from public property under its contract for such services in the city or county in which the towing occurs. If such city or county has no such contract, the rate could not be more than the amount that the city of the metropolitan class would pay for towing services from public property under its contract for such services.

The bill was met with opposition from the towing industry and never moved out of Committee.

Another bill heard by the Transportation Committee on the same day was passed. As amended, LB 1065, introduced by Senator Lavon Heidemann, Elk Creek, changes the number of days a towing company has to notify any lienholder and the owner of the vehicle. Current law states 30 days and the bill changes the notification to 15 days. It also adds language stating that "Upon payment of towing and storage charges, the person towing or storing the vehicle shall return posses-

sion of the vehicle to the (a) owner, (b) lienholder, or any other person lawfully entitled to the possession of such vehicle making payment of such charges.

The law takes affect 90 days after the end of the Session (July 14, 2010.)

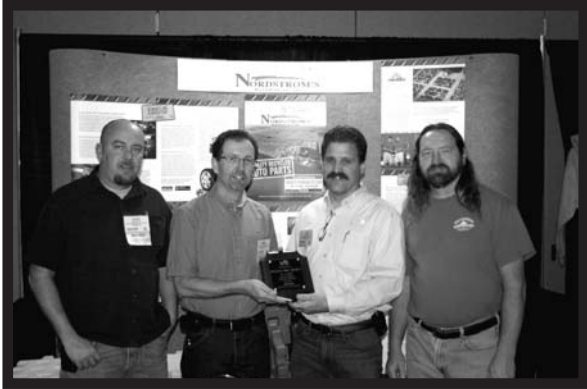

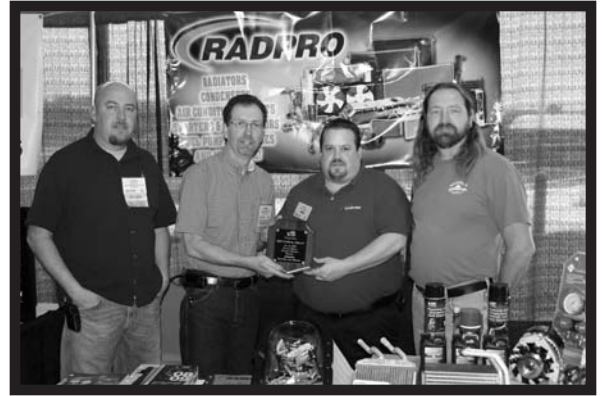

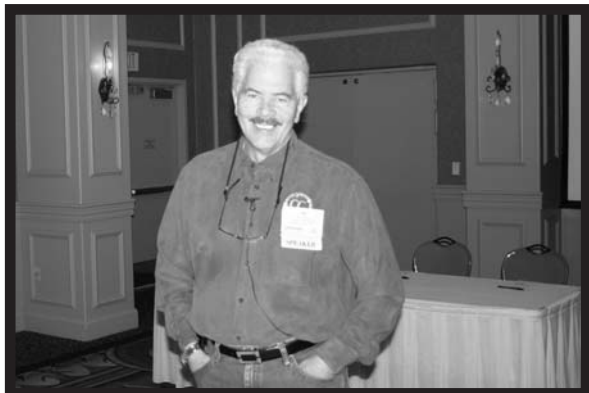
